Brown Act:

The legislative body of a local agency may use teleconferencing in connection with any meeting or proceeding authorized by law. Cal. Gov't Code §54953(b)(1). A "teleconference" is "a meeting of a legislative body, the members of which are in different locations, connected by electronic means, through either audio or video, or both." Cal. Gov't Code § 54953(b)(4). A local agency may provide the public with additional teleconference locations. Cal. Gov't Code § 54953(b)(4).

The teleconferenced meeting must meet the following requirements:

- (1) it must comply with all of the Act's requirements applicable to other meetings;
- (2) all votes must be taken by roll call;
- (3) agendas must be posted at all teleconference locations and the meeting must be conducted in a manner that protects the statutory and constitutional rights of the parties or public appearing before the body;
- (4) each teleconference location must be identified in the notice and agenda and each location must be accessible to the public;
- (5) during the teleconferenced meeting, at least a quorum of the members of the legislative body must participate from locations within the boundaries of the body's jurisdiction; and

(6) the agenda must provide the public with an opportunity to address the legislative body at each teleconference location. Cal. Gov't Co).

Sierra

Notices

Holds Pick-up notices and Courtesy notices have started going out normally again. We are still not sending overdue notices or bills out yet, and will phase that in gradually in the next few weeks.

• Fines in PayPal

As we prepared to distribute the fines money back to libraries, it became apparent that we weren't getting as much back from the County's bank account as was being reported in Sierra and Bibliocommons. It turns out that people have the option to pay fines in Bibliocommons with their PayPals accounts, and especially this year it's become a popular option. This means that we have fines being credited to our PayPal account, and need to recover them somehow to pay them out. The County does not want a PayPal account connected directly to the main BofA account we use for other fines, so we are looking for alternative methods to transfer the money, now around \$25,000, back into our budget for distribution.

Auto Renew

All loan rules that allow renewals have been updated to allow autorenew. When the courtesy notice is sent (2 days before the due date) items are automatically renewed.





Firewall

The firewall project is finished, except for pulling the old firewalls out. We will be working with Dave to add monitoring software so we can troubleshoot bandwidth problems.





• Sprint

Sprint is still trying to hire a new driver. Bill continues to fill in and is doing a great job with the ever changing schedule.

• Unity – LinkPlus delivery

Unity will resume the LinkPlus delivery this week, in order to clear out all the backlogged items everywhere. July 27^{th.} is the first day that LinkPlus is expected to fill holds again. Each library can decide when they are ready to rejoin and let Amy Homick of III know the date.



Circulation

Even though the libraries have opened for curbside and CWG says curbside is very popular, Overdrive is not seeing much of a decrease in holds or circulation. June had over 54,000 circulations. We currently have 39,004 Overdrive holds. (In comparison, we have 42,250 holds on physical items, of which 3,894 are frozen.)

• RBDigital/Overdrive Magazines

OverDrive announced that it is acquiring the assets of RBmedia's library business, including the RBdigital platform. Over the coming months, all RBdigital customers will be migrated to the OverDrive platform which will be enhanced to deliver additional Recorded Books audiobooks. Moreover, OverDrive will be exploring the addition of popular RBdigital services like digital magazines from our partner ZINIO, to the OverDrive platform. After the customer and patron migration is complete, the RBdigital platform will be discontinued.

Jessica switched our RBDigital subscription over to a new version that gives patrons access to thousands of titles, as opposed to the 80 that we individually curated. So far it sounds like Overdrive will honor that subscription when we move from RBDigital to Overdrive and we will continue to have access to all the magazines at our current price.
