# Working from home, updates

Connie is mostly in the office, Jessica and Dan are in one or two days a week and the rest is from home, and Giao is working entirely from home. We are trying to keep the staff density as low as possible in our 650 square foot office.

#### **Notices**

We are still not sending out Overdue notices or Bills. It's time to restart these now, we just need to figure out how to phase them in so as not to send a massive batch of confusing notices out.

## Fines and well, more Fines

Dan audited the fines counting process this month, and found that we have fines built up in our PayPal account, and beyond that we undercounted overdue fines paid in Bibliocommons for the last 2 years, some of which is this PayPal money. In calculating the fines distributions, we were undercounting overdues paid in BC by about 50% for 2 years. This was fixed for the FY 19-20 distribution of fines, but there is a backlog from FY 17-18 and FY 18-19 of about \$63,000. (That includes the PayPal funds.) We can calculate a distribution on these older funds, it if that is the Board's decision this month. All these fines were being counted as part of our bottom-line funds, so they weren't completely lost. But we'd never audited how much remained in the deposit account for fines to see if there was a running balance, until now.

To recover the PayPal funds, we are probably going to have to set up a bank account. The County will not allow PayPal to link to their accounts, which is how we currently transfer fines paid by credit cards. And PayPal will not allow us to transfer or pay anything with our balance until we are "verified" which tax exemption info as well as a bank account to link to.



# Sprint

# Unity – LinkPlus delivery

Unity resumed the LinkPlus delivery on schedule on July 27. For right now, we are not sending or receiving a delivery on Fridays, as covering




the sorting is still a challenge. We intend to resume delivery on Fridays in September. LinkPlus looks to be running at about ½ of preclosure volumes. Several of our major "trading partners" have also not come back in yet, such as SFPL, Oakland PL and Contra Costa County PL. Meanwhile Coronado Public Library has gone live in the LinkPlus system.




## Circulation

Physical circulation is rebounding, but still only at 30 percent of what it was when buildings were open. (This is checkouts, not including renewals.)



Overdrive circulation in July was still over 34,000, about the same as in May and June. All records are being broken here.
