 - i. There is no way to renew library cards automatically in Innovative. Is there a way to make renewing a card easier? Discussion of extended and no expiration date.
 - Discussion of collections and allowing patrons to change address. Discussing these issues with Circ committee would be useful. Dan will explore other Innovative users' ways of dealing with these issues.
- c. MARINet 25th Anniversary. Passport project design is beginning. Discussion of number of squares for stamps. Linda will be sending out information about stamps for us to submit logos. Services could have stamps: database, Discover and Go, LINK+. Is there a way to get transportation for patrons who need it? Anniversary webpage has interesting content.
- d. **CENIC Califa contract and resolution.** MARINet must pay for first year. After that, State Library pays. Sinking funds are being used.

- Discussion of expense, impact on the Sinking Fund, structure of libraries' contributions. How should we think of the sinking fund? We could think of it as an "Opportunity Fund."
- ii. Motion: The board approves the MARINet staff to sign the contract with Califa for CENIC bandwidth and continue to work with Califa, CENIC and Marin IT Inc. staff for the design and construction of this new network. Unanimous approval.
